

INSTALLATION INSTRUCTIONS

1. Unwrap and lay out all pieces.
2. Install the wheels:
 - a. Locate the wheel axel; it will have a pin in each end, two washers, and two barrels.
 - b. Remove one end pin by bending the tines straight, sliding off all of the other hardware with the exception of one washer.
 - c. Insert the axel through one wheel, then add a barrel piece.
 - d. Slide the axel through the welded tubes on the base of the jack frame.
 - e. Add the second barrel to the axel, followed by the second wheel and the second washer.
 - f. Insert the pin through the axel, bending it to keep it in place.



3. Locate the winch assembly arm; remove the nut and washer from the winch's handle assembly, sliding on the handle and reattaching the washer and nut.



4. Unroll the winch cable so that there is enough slack to move the upper beam above the jack frame piece.



5. Align the upper beam with the jack frame piece; make sure that the cable is not twisted around the beams. If the jack is being assembled with the base plate downward, the kickstand will be on the right side of the beam looking from the wheels. Make sure the cable runs straight from the winch to the pulley at the top of the upper beam.

6. Remove the bolts in the bottom of the upper beam; slide the beam onto the jack frame insert, replacing and tightening the bolts.



The newly assembled frame tent jack is now ready to use.

Notable features:

- The kick stand on the upper beam portion is for use if the jack is laid down on the ground with the winch down; this keeps the winch handle from hitting the ground and bending. The kick stand operates on a dimple lock system when not in use, where a nub on the stand aligns with a hold in the upper beam to keep it in place when not in use.



- For added stability, tent stakes may be inserted into the four welded tubes on the base to add area to the jack base. Simply slide the stakes in toward the center of the base.
